Sub: Format of Interrogation Report forpersons arrested in Human Trafficking Cases

Trafficking in human beings for purpose of forced labour, domestic servitude, child begging, removal of organs or commercial sexual exploitation are despicable crimes affecting mostly women and children. Combating such organized crime requires a comprehensive approach to trace origin, transit and destination of the offence. However, it has been observed that the statement of the accused persons arrested in the trafficking cases are often very sketchy which barely bring out the background, network linkages, finances of the traffickers. As a result, no systematic database is available on traffickers including recruiters, buyers, sellers, harbourers, transporters, financers, customers etc.

Hence, a format of Interrogation Report (IR) of the accused arrested in the trafficking cases (including 370, 370A, 371, 372, 373, 374 IPC, Immoral Trafficking (Prevention) Act, 1956, Interstate Migrant Workers (Regulation of Employment & Condition of Service) Act, 1979 has been developed and is enclosed as <a href="Annexure-A">Annexure-A</a>. The Superintendents of Police/Dy Commissioner of Police are instructed to advise field officers investigating trafficking cases to prepare IR of the trafficker(s) arrested in the case in the said format with a view to develop a database on traffickers and their network. While recording individual details of the trafficker, efforts should be made to elicit details like Driving License, Passport details and Adhar Card to ascertain authenticated identity of the accused. The IRs should be kept with IAHTU Section of the district and one copy of all such IRs should be sent to State Nodal Office of IAHTU at CAW&CW.
