In exercise of power conferred under sub-section (2) of section 107 of the Juvenile Justice (Care and Protection of Children) Act. 2015 (hereinafter referred to as "the Act") read with provisions contained under sub-rule (1) of rule 86 of the Juvenile Justice (Care and Protection of Children) Model Rules, 2016 the State Government do hereby constitute the Special Juvenile Police Unit (SJPU) in respect of every district and city to coordinate all functions of police related to children.

1 The Special Juvenile Police Units so constituted (including urban police districts and Government Railway Police districts) of the State of Odisha shall have the following composition:

- The Special Juvenile Police Units shall function in consonance with the provisions prescribed under the Act and Rules framed there under.
- 3. The Special Juvenile Police Unit inter alia shall work in close co-ordination with the District Child Protection Unit, the Juvenile Justice Board and the Child Welfare Committee in the matters concerning the welfare of children within its jurisdiction.
- 4. The Special Juvenile Police Unit may coordinate with the District Legal Services Authority to provide legal aid to children.

This order will come into force with immediate effect and supersedes the Notification No. 37757 Dated 24<sup>th</sup> September 2012 and No. 37761 Dated 24.09.2012 of this Department.
